
AFFECTED PRODUCTS	Patient support (NC989001087431)
PROBLEM DESCRIPTION	 The footplate of the Patient support for stitching can be fixed in upper position. When the fixing clamp (hook) is not in its correct looking position, the footplate is not securely held. If it falls down, it may hurt the operator's or patient's foot or leg (e.g. when moving the stand or when the operator fails to fix it correctly upon moving the footplate up). Following factors are needed that the situation occurs: Hinges are worn differently on both sides Hook does not hold Operator does not check that the hook securely holds the footplate Footplate falls unexpectedly when touched or during transport Foot or leg in "target area"
HAZARD INVOLVED	The hook does not securely hold the footplate in vertical position. Therefore, the footplate can fall or swing down and may hurt the operator or patient.
