Description of the problem:

Hill-Rom has become aware the Strap Gripper accessory used with the Liko[®] MultirallTM 200 may have been assembled incorrectly during manufacturing. To date, Hill-Rom has received one complaint, where it was confirmed the accessory was incorrectly assembled. If the incorrectly assembled Strap gripper accessory as shown below is used during patient transfer, this could allow the patient to fall, resulting in potential injury to the patient. There have been no injuries reported to Hill-Rom for this issue. It is with an abundance of caution that Hill-Rom is notifying end users who have purchased any strap gripper accessories of this issue.





Action to be taken by the user:

- Immediately locate your Strap Gripper accessory. Use the photo above to inspect the strap gripper accessory to verify that the unit has been assembled correctly. The left side of the photo shows a correctly assembled unit, and the right side shows an incorrectly assembled unit.
- Immediately remove any incorrectly assembled units from use.
- Contact your Hill-Rom representative to coordinate the return and replacement of any incorrectly assembled units.
- Correctly assembled strap grippers accessories may continue to be used.
- Complete the attached response form and return within 15 days.
