We would like to inform you that PARI GmbH has decided to recall the following batch of our PARI LC SPRINT Tracheo from the market because of a picking error:

Description of problem and patient risk:

The affected batch includes instead of the LC tracheal adapter a wrong tracheal adapter which has no exhalation holes. Hence, a patient with a blocked tracheal cannula would not be able to exhale during therapy and would experience dyspnoea in a worst case. Therefore, PARI has decided to recall this batch.
