

## **URGENT – VOLUNTARY PRODUCT RECALL**

## Dear Customer,

We are writing to notify you that EKOS is voluntarily recalling and replacing the above referenced component of the EKOS Control Unit 4.0 that is located at your facility. EKOS recently became aware that the indicator label affixed on the Connector Interface Cable (CIC; Catalog Number 700-10410) component of the EKOS Control Unit 4.0, may be misoriented. We have provided a side-by-side comparison of correct and incorrect orientation of the indicator label in Figure 1 below.

The purpose of this secondary indicator label is to indicate the active running channel while administering therapy using the EkoSonic Endovascular Device. If the label is incorrectly oriented, as shown in Figure 1 (b), the 'blue' color would indicate the *incorrect* running channel. The primary indicators on the EKOS Control Unit

4.0, i.e., the timer and green highlighted active channel on the Control Unit 4.0 front panel are accurate; the incorrect orientation of the secondary indicator label does not affect these primary indicators. The schematic of the EKOS Control Unit 4.0 showing these primary indicators are shown in Figure 2.

On-screen indicators

No patient injuries have been reported as a result of this incorrect label orientation, and the health hazard associated with this labeling discrepancy has been determined to be 'Low'. The cause of this discrepancy has been corrected and labels on all future units will be correctly oriented.

Our records indicate you have purchased one or more affected CIC unit(s), and EKOS wants to ensure you are notified of this labeling discrepancy. Your local BTG Representative/authorized distributor will contact you within a week to make an appointment to switch out your current Connector Interface Cable with a replacement component.

We sincerely regret any inconvenience this may cause to you or your facility.
