**RE**: Update of Olea Sphere V3.0 IFU

This notification is intended to alert our users to the optimal usage of our Olea Sphere V3.0 software.

Given the relative novelty of SMS/multi-band type of acquisition and the lack of consensus in the current state of the art about this type of acquisition, Olea Medical inform its users that the produced images with this type of acquisition can be loaded and visualized with Olea Sphere V3.0 software, but Olea Medical do not recommend to use Olea Sphere V3.0 software to derive quantitative parameters (e.g.ADC) and let alone use these quantitative parameters to identify, delineate abnormalities and estimate volumes of interest.

#### Consequence

The SMS/multi-band type of acquisition could potentially lead to errors for the estimation of the quantitative parameters like ADC, this could potentially impact the interpretation of these parameters.

No incidents were reported regarding the estimation of quantitative parameters.

### Corrective action implemented by Olea Medical:

Olea Medical provides you the updated user guide containing information about SMS/multi-band acquisition:

- Warning for modules Diffusion Weighted Imaging (DWI) and Analysis
- ➤ Note for modules **Diffusion Tensor Imaging (DTI)** and **IntraVoxel Incoherent Motion** (IVIM)
