



## <u>URGENT: FIELD SAFETY NOTICE - PAS-19-1454</u>

#### **BD Microtainer® Tubes**

Type of Action: Product Removal

#### Attention: Clinical Personnel, Risk Managers, Biomedical Personnel

This letter contains important information which requires your **immediate** attention.

Dear valued Customer,

BD is conducting a Field Safety Corrective Action to remove specific lots of the BD Microtainer® Tubes due to the potential for damaged tubes. According to our distribution records your organisation may have received the impacted devices.

#### **Description of the Problem**

The affected devices are being removed from the market as there is the potential for blood leakage due to a hole or damage at the base of the BD Microtainer® Tube. This defect could result in blood exposure from the leaked sample or potential erroneous results due to an inappropriate blood-to-additive ratio. Patients may need to be re-sampled, which may lead to a delay in treatment.

This product removal is limited to the product codes / lot numbers listed in Appendix 1, no other product codes / lot numbers are affected.

#### **Actions for Customers to take:**

- Please inspect your inventory and locate and quarantine any unused device/s of any of the impacted lot numbers. Destroy all impacted devices or return to your BD local representative / distributor to be destroyed.
- 2. If you have further distributed the device/s, please identify those users and notify them at once of this product removal.
- 3. BD recommends discussing the content of this letter with your laboratory director regarding the need to review previous test results associated with these affected lots.


