URGENT FIELD SAFETY NOTICE

Nobel Biocare identified a packaging issue affecting the following medical devices:

Our records indicate that you purchased a device that may potentially be affected. This notice is intended to inform you about the issue, the actions that should be taken and the actions planned by Nobel Biocare to correct the issue.

Issue description

Packages of above mentioned abutment lots may contain an incorrect screw. The figure below shows an example of a correct and incorrect screw.



Figure 1: Incorrect screw (left, article 37893: Screw Multi-unit Abut Angled CC RP/WP) versus correct screw (right, article 37892: Clinical Screw CC RP/WP)

Potential hazard

The screw will tighten, however it cannot be guaranteed that the screw will not loosen. In case the screw loosens the abutment should be retightened with the correct screw.

**Actions to be taken
by customers**

1. Identify all devices in your stock from the affected lots. Attached Customer Acknowledgment Form indicates which of the lots you purchased according to our records.
2. Do not use devices from the affected lots.
