Description of the problem including the identified cause:

KARL STORZ Endoskope is aware of cases in which the cover glasses of the camera and/or the LED lighting on the video laryngoscopes were no longer present after reprocessing. There are no known cases involving patients.

There is a risk that unnoticed damage to the cover glasses could cause them to come loose during use.

What measures are to be taken by the addressee?

Please read this safety information carefully and forward it to the appropriate places in your organization.

Destroy the outdated manuals for the C-MAC[®] video laryngoscope. Replace the operating instructions with the updated version (download via <u>https://www.karlstorz.com/de/en/media-library.htm</u> 96076011D for C-MAC[®] 8401XX and for 96076019D for C-MAC[®] 8403XX). A printed edition is available on request.

Train your employees on the new instructions for use, especially chapter 5.1 and the validated reprocessing procedures, as well as the approved chemicals – chapter 7.2

Fill in the attached reply and return it to KARL STORZ Endoskope. This confirms that all old instructions for use have been destroyed and that the personnel have been trained in the new instructions for use.

No further treatment is required for treated patients.

If you have carefully checked the laryngoscope before and after use according to the old instructions for use, there is no danger for the patients/users/third parties.
