#### **Description of the issue**

Based on fertility issues with Cetrimide Agar (Ref. 43565) reported from the field, bioMérieux initiated a complaint investigation to confirm product issue and determine root cause.

The following have been identified:

- ⇒ The investigation confirmed a fertility issue on lot.#1007530990 of Cetrimide Agar (Ref. 43565). We observed a low growth of *Pseudomonas aeruginosa* ATCC 10145
- ⇒ No false negative results were observed during testing for *Pseudomonas aeruginosa* ATCC 10145.
- ⇒ We did not receive any complaints from clinical customers due to referenced issue.
- ⇒ The impacted lot was conform to the specifications during the Quality Control release testing, therefore the issue appears over the product shelf life and could be related to a stability issue.



#### **Impact to customer:**

 Based on the investigation results, there is a potential risk for False negative results for Pseudomonas aeruginosa with lot. # 1007530990 of Cetrimide Agar (Ref. 43565) – in Table 1 when used in Medical bacteriology.
