## URGENT: PRODUCT ADVISORY NOTICE HALYARD\* CLOSED SUCTION SYSTEM FOR NEONATES/PEDIATRICS (5 Fr)

November 4, 2019

Dear Valued Avanos Customer:

#### What is the Reason for this Product Advisory Notice?

Avanos Medical has received reports stating that the central lumen of some 5 Fr Neonate/Pediatric Closed Suction Catheters may be occluded (approximately 0.045% based on complaints of distributed units). This may cause the closed suction catheters (CSCs) to not suction secretions and/or saline fluids from the patient's airway to prevent oxygen desaturation.

If an occlusion is present, the blockage is NOT visible to the user; however, a blockage is detectable before catheter use by testing suctioning effectiveness. The risk of a CSC blockage to patient's health can be life threatening since the CSC is not able to suction out any fluids that may obstruct the airway/ ET tube.

Customers should confirm that the potentially impacted 5 Fr CSC products can adequately suction before use on a patient and/or before introducing saline. *If the CSC appears occluded, users should not use and immediately replace the product.* The Instructions For Use (IFU) reminds the clinician to note any signs of suction intolerance, which include oxygen desaturation, negative ventilator system pressures, patient stress, or excessive discomfort and may require the use of an alternate suction technique.

#### Which Products are Impacted?

This Product Advisory Notice applies to the **HALYARD**\* **Closed Suction System for Neonates/Pediatrics (5 Fr only).** The potentially affected product codes are listed in the following table (see Table 1). Please note that all potentially affected lots were shipped beginning June 1, 2018 and ending October 23, 2019.
