URGENT FIELD SAFETY NOTICE

With this letter we would like to inform you about the recall of defibrillation electrodes concerning the article mentioned below:

Please read this letter carefully and follow the steps in section 2 of this letter.

1. Description of Fault

Summary: In the course of an investigation triggered by a complaint, it was discovered that there is a possible contact problem between electrode and ring terminal in the mentioned lot number. The contact between electrode and defibrillator may be interrupted or partially interrupted.

Identification of the Affected Product

Electrodes with REF 04324.3 and LOT 190711-3993 are affected.

Example: affected electrodes (imprint case)



Electrodes with the same REF but different LOT number are not affected.



Potential risk: There is a potential risk that no signals or energy will be transmitted. This can result in failure to treat a patient in a life-threatening condition requiring a defibrillation shock on time.

Condition for occurrence of the error: Use of defibrillation electrodes with REF 04324.3 and the lot number 190711-3993 with a compatible defibrillator.

Safety information: With this letter, Leonhard Lang informs you of the fact that this field safety notice (short: FSN) will also be forwarded to the competent authorities. Please note that under existing legislation (Medical Device Regulation) you are obliged to comply with the requirements of this recall action.

2. Process for the Recall

- a.) Please read this FSN carefully. If you have any questions or are unable to implement the required measures, please instantly contact the organization that provided you with this FSN.
- b.) Please ensure in your organization that all users and other persons concerned are aware of this urgent FSN.
- c.) If you should have affected electrodes **in storage**, ensure that they are not sold or passed on. Sort out the electrodes and **destroy** them <u>immediately</u>.

If you should have affected electrodes **in use**, ensure that you have at least one spare pair in reserve, if possible, until the electrodes have been replaced.

If you have **sold** the affected electrodes or **passed** them on **to third parties**, please forward this FSN to these customers <u>immediately</u>.

d.) Please fill out the Recall response form attached and return your response form to the organization that sent you this FSN by **March 31, 2020** at the latest.

Please note: If the feedback from your customers is not complete, you are obliged to take active measures to ensure that you receive the outstanding data.

3. Replacement Electrodes

After you have forwarded the Recall response form to the organization that sent you this safety information, you will receive replacement electrodes, with the same REF 04324.3, but with a different lot number. Replace them immediately and destroy the replaced electrodes.

If you have resold or passed on electrodes, you are asked to provide your customers with replacement electrodes.



We apologize very much for the inconvenience caused. In order for patients and users to be able to use our products safely, however, it is absolutely essential that these measures are carried out immediately.
