## Description of the problem including the identified cause:

Karl Storz has been informed that the low pressure CO2 tubes stated above may contain an incorrect component in the connecting plug. The diameter of the component deviates from the specified dimension.

Inadvertently connecting the CO2 plug to an O2 connection point may result in a flow of gas under certain circumstances. The CO2 plug will not engage fully in the O2 connection point; however, it is possible that, if a misaligned connection is established and tension is therefore exerted on the tube, the plug may become wedged in the connection point, resulting in a flow of gas. If connected correctly, the plug would have to be pushed all the way into the O2 connection point in order to establish a constant gas flow.

The potentially affected low pressure CO2 tubes are correctly labeled with CO2 and, in accordance with the instructions for use, are not intended for use with O2.

The insufflation of O2 and the use of HF surgical instruments could cause reversible or irreversible injuries to patients. No such incidents have been reported in connection with this problem to date.




Figure 1: Correct inner diameter 5.9 +0.12 mm




Figure 2: Incorrect inner diameter
