URGENT FIELD SAFETY NOTICE

Pall Breathing System Filter (For Ventilator Machine End and Medical Gas Equipment Applications)

Description of the problem:

The Pall Breathing System Filter for machine end and medical gas equipment applications (product code BB50TES) is a highly efficient bi-directional bacterial/viral filter. The product is provided "Sterilised by Irradiation" as indicated by the product labelling.

Pall has recently identified that one lot number of Pall Breathing System Filters (product code BB50TES) has not been sterilised correctly as the product was not irradiated with the full, validated minimum sterilisation dose that is required to ensure the sterility status identified on the product labelling. The affected lot number is identified in the table above. An investigation to determine the root cause of this issue is in progress. This investigation will include identifying and implementing any appropriate corrective actions.

It has been determined that the use of Pall Breathing System Filters (product code BB50TES) from the affected lot presents a low probability of harm to a patient as Pall Breathing System Filters are available



as both sterile and non-sterile product variants, which in practice, are used in the same manner in gas filtration applications. Furthermore, sterile Pall Breathing System Filters (product code BB50TES) are not used in a controlled environment within the clinical setting and as such, are not considered sterile once the unit packaging for the device has been opened.

As the Pall Breathing System Filters (product code BB50TES) with the lot number identified in the table above have not been supplied in accordance with our specification for sterility, Pall has decided to recall the implicated product. It is advised that any such filters be removed from clinical use and replaced with filters from another lot.

Advice on action to be taken by the user:

Please immediately identify and quarantine Pall Breathing System Filters (product code BB50TES) with the lot number identified in the table above. Quarantined units can be destroyed or returned to Pall.

Please complete the attached acknowledgement form and return it to <Contact Name> by email <contact name>@pall.com. <Contact Name> will arrange return of the quarantined units, if applicable, and will be in contact with you regarding replacement of affected product.
