Type of Action: Notification of the instruction manual revision

Dear Customers,

FUJIFILM is issuing this Field Safety Notice for our Endoscope types EG-760R, EG-760Z, EC-760R-V/M, EC-760R-V/I, EC-760R-V/L, EC-760ZP-V/M, EC-760ZP-V/L and Ultrasonic Endoscope EG-580UT and EG-580UR.

This Field Safety Notice is intended to inform you about the following:

- what the problem is
- the actions that should be taken by the customer/user

This document contains important information for the continued safe and proper use of your equipment.

Please review the following information with all members of your staff who need to be aware of the contents of this communication. It is important to understand the implications of this communication.

Description of the problem

In case the cleaning brush will be damaged inside the channel during the scope cleaning, it is instructed by the operation manual to remove any residue from inside the channel using a spare brush. If residue remains inside the channel, it could be a source of infection. However, in case of the combination of the cleaning brush WB7024FW and the affected endoscope models, we become aware that residue of the cleaning brush cannot be removed in rare cases with this method.

FUJIFILM will provide the revised instruction manual "Cleaning, Disinfection and Storage". Please follow the revised instruction manuals after this. In particular, please keep the following points in mind.

- Carefully inspect all cleaning brushes for abnormalities and/or damage prior to use and after every brushing.
- In case the cleaning brush is damaged during cleaning, and if residue is not completely removed even with the spare brush, have the endoscope repaired immediately.

Actions to be taken by customer/user

- (1) According to the procedure of the revised instruction manuals, please conduct cleaning and disinfecting for target product.
- (2) Please discard all instruction manuals of the previous version.
