Reason for the FSN

In the course of our post market surveillance activities we observed that one component of the kit has a shelf life approximately one month shorter than the complete kit (see picture below). Whilst the Sterican Safety Needle has a shelf life until 2024–04–01 the complete kit has a shelf life until 2024–05–05. The described failure is limited to the above mentioned product and batch number. No other kits or batches are affected by this Field Safety Notice.

There is a minor risk of using a Sterican Safety Needle for injection, which is out of shelf life. Injury to patients is very unlikely. Under these conditions we advise the following actions:
