Call back of Sterile single use devices (TRANBERG® | Laser Applicator, TRANBERG® | Introducer / TRANBERG® | Tissue Temp Probe) for the TRANBERG®Thermal Therapy System

At CLS, our commitment is to never compromise on safety compliance or quality of our products and services.

March 31, 2021, SterilMilano, the service provider of sterilization of CLS 'sterile single use devices, informed us that they cannot guarantee that the validation of the sterilization process of our products has been properly conducted (validation performed 2014 and revalidation performed 2018). They have found traces of fraud in several stages of the operations and cannot define the extension and impact of these events.

Based on this information, CLS concludes there is a potential risk that delivered products do not fulfill the defined sterility assurance level (SAL of 10–6) and should therefore not be used in treatments any longer.

We have therefor decided to call back products that have been distributed to our cooperation partners and customers.

As of now these products are on hold at CLS own stock. We consider that there is no risk for patient harm from already used products.
