Re: Notice of falsification of medical devices manufactured by Fin-Ceramica Faenza S.p.A. and similar for type to MaioRegen (Internal Ref. NC 008/22)

Fin-Ceramica Faenza S.p.A., as the manufacturer of the medical devices, similar for type to **MaioRegen** hereby gives notice that a Turkish economic operator has communicated the existence of falsified medical devices in Turkey with falsified packaging and potentially altered contents.

At present, the presence of such falsified medical devices cannot be excluded on the Italian and European territory.

To date, the manufacturer has not been able to analyse the products subject to falsification since they are not available.

They bear the logo no longer in use but similar to the originals of the manufacturer and the name “cartilage layer”.


