
We inform you that a user of these kits observed a labelling inversion between the two pathological controls MS and MZ. The MS vials has the labelling of the MZ one and vice versa.

This labelling inversion concerns two lots of A1AT controls kits:

- 28022/01 (contains MM lot: 28022/01, MS lot: 02032/01 and MZ lot: 01032/01)
- 28022/02 ((contains MM lot: 28022/02, MS lot: 02032/02 and MZ lot: 01032/02)

As a reminder, as described in the package insert of the A1AT CONTROLS, the A1AT Controls are designed for the migration control of the human Alpha-1 antitrypsin isoforms pattern obtained with HYDRAGEL 18 A1AT ISOFOCUSING* isoelectric-focusing procedure. The A1AT Controls should be used as human sera.

Despite, the labelling inversion of the two pathological controls (MS and MZ), the three controls (MM, MS and MZ) migrate as expected and provide the three phenotypes needed M, S and Z (see example of gel below):

Based on the availability of the three controls phenotypes, there is no expected impact on patient results.

Our traceability indicates that you received one of this batch number, therefore, we kindly ask you to:

- Destruct or return to Sebia all remaining kits of AIAT controls of the incriminated lots in your possession.
- 2. Fill-in the enclosed form, precisely indicate the number of kits in your possession, the number of kits destroyed or returned to Sebia. Send back all the forms by e-mail to your local SEBIA contact.
