Maquet Cardiopulmonary GmbH (MCP) would like to inform with this letter about the possible blocking of the CARDIOHELP Emergency Drives.

The CARDIOHELP system is a miniaturized medical perfusion system. Its general function is to drive, to control, to monitor and to protocol the extracorporeal circulation. It acts as a drive unit for a disposable tubing set including at least pump and oxygenator. The CARDIOHELP Emergency Drive (Figure 1) is used in emergencies to manually drive the disposable if the CARDIOHELP-i fails.




Figure 2: Draft of the position of the safety washer

Problem description

Maquet Cardiopulmonary GmbH became aware of the issue due to a customer complaint. It was reported that the rotation of the CARDIOHELP Emergency Drive hand crank was blocked or impaired. In course of internal investigations, it was found that the safety washer causes this issue. The safety washer was originally

introduced to the CARDIOHELP Emergency Drive in order to lengthen the shaft of the Emergency Drive by the thickness of the safety washer, thus, reducing the axial pressure on the circlip, safety washer and bearing (Figure 2).

Hazardous situation

Insufficient rotation due to an impaired or blocked CARDIOHELP Emergency Drive can lead to the following hazardous situation:

The patient is exposed to inappropriate low blood flow.

Potential harms

The potential immediate and/or long-range health consequences associated with an impaired function of the CARDIOHELP Emergency Drive may be any, all, or none of following harms:

- Ischemia
- Hypoxia

Maquet Cardiopulmonary GmbH has identified four complaints due to failure modes described above, however, none reporting patient harm, serious injuries, or deaths.

For CARDIOHELPs with affected Emergency Drives currently not being used in patient treatment:

Affected Emergency Drives are not requested to be returned, however, shall be quarantined and not be used until the removal of the safety washer. A local Getinge representative will contact you to arrange the removal of the safety washer.
