Risk Addressed by FSN

1. Information on Affected Devices

1. Device Type(s)

Dilators are designed with gradual tapers, may include hydrophilic coating, and are available in multiple inner and outer diameter and length combinations.

1. The Entuit™ Secure Adjustable Gastrointestinal Suture Anchor Set consists of two or three introducer needles with preloaded anchors and a .035 inch wire guide.

The Chiba Biopsy Needle is ideal for initial access and biopsy. The match-ground bevelled tip provides steerability. The Chiba needle that features EchoTip® enhances visibility under ultrasound.

Dilators - Coons Taper are intended to be used for dilating puncture sites or catheter tracts for percutaneous placement of devices for vascular and non-vascular applications such as in the venous, arterial, biliary and renal systems.

 Entuit™ Secure Adjustable Gastrointestinal Suture Anchor Sets are intended for anchoring the anterior wall of the stomach to the abdominal wall prior to introduction of interventional catheters.

Chiba Biopsy Needles are intended for used for aspiration biopsy.

2. Reason for Field Safety Corrective Action (FSCA)

1. Description of the product problem

Cook Medical identified that devices from the affected device lots may have packaging seals that do not meet peel strength specifications. This creates a potential of a sterile barrier failure that could result in compromised device sterility.

You are receiving this letter as Cook Medical records indicate that impacted products were shipped to your facility.

2. Hazard giving rise to the FSCA

The affected devices may be non-sterile or contaminated with microorganisms. Potential adverse events that may occur if an affected product is used include increased procedural time and infection, potentially being life-threatening and/or requiring medical/surgical intervention.

To date, Cook Medical has not received any customer complaints related to the adverse patient effects listed above for the affected lots. However, please be advised that compromised device sterility may go undetected by the user.
