

URGENT MEDICAL DEVICE RECALL

Kirwan Surgical Products LLC is conducting a voluntary recall on all 25-gauge disposable bipolar pencils with a sterile lot range from 220906 to 241002. Further details on the at-risk products are presented in the table below.

Description of the Problem and Health Hazard(s):

On November 9th, 2024, Kirwan Surgical Products LLC initiated a voluntary recall for the European Union, Switzerland & United Kingdom. In the United States of America an adverse event occurred that required intervention to prevent permanent impairment /damage. The Device in question is a Kirwan brand disposable 25-gauge bipolar pencil, straight (14-5011). The protective sheath came off when the surgeon removed the instrument from the right eye. The sheath stayed in the eye and poked a hole in the retina. The sheath is made from 25GA stainless steel tubing. Medical intervention was performed and prevented permanent damage. Due to this fact, it has been determined that a recall of all at risk 25GA pencils out in the field shall be immediately implemented.

Upon review of this event report and upon review of similar customer complaints, this issue affects an overall small percentage of 25 Gauge bipolar pencils built (<0.1%), however there has been an increase in reported complaints over the past 6 months. There have been two injuries in total, one minor, and one serious that required intervention to prevent damage. The recent increase in occurrence and potential severity evidenced by trend analysis is cause for concern and is the impetus behind carrying out this recall.

Our records indicate you have been shipped product referenced in the table above.

Please Take the Following Actions:

- 1. We have asked that if the distributor is in possession of any 25GA disposable bipolar pencils with the following SKUs (14-5011, 14-5011L) with a sterile lot range from 220906 to 241002, please return it to the Kirwan Surgical Products LLC facility.
- 2. Please identify all customers within your distribution network that have received 25GA disposable bipolar pencils with the following SKUs (14-5011, 14-5011L) with a sterile lot range from 220906 to 241002, and please ask that your customers return any product still in their possession to the respective distributor, or Kirwan Surgical Products LLC facility.
- 3. Complete the attached Distributor Response Form and return to the KSP LLC noted contact.
